2025 Sioux Falls Summer Photo Contest Official Rules

The following contest is intended for viewing in the 50 United States and shall only be construed and evaluated according to United States law. No purchase necessary. Void where prohibited by law. Participation constitutes entrant's full agreement and acceptance to these rules.

The 2025 Sioux Falls Summer Photo Contest ("contest") is hosted by Experience Sioux Falls ("administrator"). The contest is open to legal residents of the 50 United States who are at least 18 years of age and have a physical address in the United States.
