

## **The Summit League Basketball Championships 2024 Bracket Challenge Official Rules**

The following sweepstakes is intended for viewing in the 50 United States and shall only be construed and evaluated according to United States law. No purchase necessary. Void where prohibited by law. Participation constitutes entrant's full agreement and acceptance to these rules.

The Summit League Basketball Championships 2024 Bracket Challenge promotion ("sweepstakes") is hosted by Experience Sioux Falls ("administrator"). The sweepstakes is open to legal residents of the 50 United States who are at least 18 years of age and have a physical address in the United States. This promotion is governed by US law and is subject to all applicable federal, state and local laws and regulations.
